



A NATION DECEIVED: HOW AMERICA WENT FROM CHASTITY TO CONDOMS IN ONE GENERATION

In 1948 Dr. Alfred Kinsey published Sexual Behavior in the Human Male followed by Sexual Behavior in the Human Female in 1953. These “Kinsey Reports” were the basis for a revolution that sanctioned promiscuity, pornography and homosexuality.

Dr. Kinsey and his associates helped change our nation’s thinking about sexuality. His fraudulent research is taught as fact at every level of education. Kinsey’s unchallenged conclusions permeate our schools, our psychiatric and health professions, our laws, our government, our mass media, our entertainment industry, and even many churches today.

Kinsey rejected biblical and traditional moral standards for sexual behavior. He promoted an amoral standard of sexual behavior with an animalistic view of sex for pleasure. He concluded that no sex conduct was abnormal. It is Kinsey’s “sex science” that has led to horrendous legal and social consequences with our children paying the price.

KINSEY’S METHODS

Although Dr. Kinsey was the first to legitimize “sex science” in America, he was not a scientist. He was a propagandist who used unscientific methods utilizing data that was forced, anonymous and secretly modified at will.

Rather than surveying a cross section of the population, Kinsey surveyed a disproportionate number of prison inmates, sex offenders, prostitutes and the like. The results gave a very different picture of sexual behavior in America and Americans began to believe it. They bought Kinsey’s lie. Dr. Kinsey’s colleagues called it his “grand scheme”.

To obtain data about the sexual behavior of children, Dr. Kinsey worked with trained pedophiles who sexually abused hundreds of children (as young as 2 months) to prove to the world that infants, toddlers and juveniles could enjoy sex pre-puberty with the help of an adult. Their sexual torture was recorded as pleasure.

KINSEY’S CONCLUSION – 3 fraudulently derived sexual myths:

- Sexuality is on a continuum, and all sexual behaviors (including adultery and sodomy) are natural, healthy and acceptable.
- Ten percent of our population is homosexual.
- Children are sexual from birth.

THE PORNOGRAPHY LINK – Hugh Hefner

Hugh Hefner became the image-maker for Kinsey. He redefined women—transforming them from the “girl next door” into “playmate.” Men soon accepted this new view of women and were willing to abandon love and procreation for sex and recreation. Kinsey’s research became the foundation for the Playboy Philosophy. Hugh Hefner later used his money to help change drug laws, abortion laws, sex laws and laws about sex education in the classroom.

THE HOMOSEXUAL LINK – Harry Hay

Harry Hay, a communist, read the Kinsey Report and declared his homosexuality. He left his wife and two children and began the Mattachine Society. He became the founder of the modern gay rights movement and the father of the political homosexual movement.

LEGAL CONSEQUENCES

Kinsey's pseudo science brought major changes in public policy and American law. He testified before legislatures advocating the removal of almost all criminal sex laws. Morris Ernst, an American Civil Liberties lawyer, designed a legal strategy to overturn America's Judeo-Christian ethics' sex laws. Ernst stated "virtually every page of the Kinsey report touches on some section of the legal code..."

With funding by the Rockefeller foundation, bar associations formed committees to study laws on sexual behavior. In 1955 the new Model Penal Code replaced the Common Law view of sex crimes. This new code eventually aided in reducing the penalties for abortion, rape, desertion, seduction, alienation of affection, wife and child battery, adultery, prostitution, soliciting for masturbation, contributing to the delinquency of a minor, sodomy, "unfit" parentage, public sexual exhibition, obscenity and the list goes on.

In 1957 the Supreme Court relaxed the legal definition of obscenity. This case was handled by Ernst. In 1961, Illinois was the first state to repeal its sodomy statute. In 1973, Dr. Mary Calderone (a Kinseyan) was cited in the Roe v. Wade ruling that legalized abortion. Also in 1973 homosexuality was removed from the list of psycho pathologies by the American Psychiatric Association.

EDUCATIONAL CONSEQUENCES

Since Kinsey claimed that children are sexual from birth, sex education classes that started in college eventually worked their way down to high school and then to all grade levels. The sex education curriculum in our schools today is based on fraud and crimes against children. Almost all AIDS education in K-12 is used to teach the Kinsey model of sexual variation to children, and at the same time rejects all moral parameters.

The Kinsey Institute continues to aggressively lobby to legalize, normalize and mainstream deviant and criminal sexual conduct. In 1964 the Kinsey Institute launched the Sex Information and Education Council of the United States (SIECUS) to teach the Kinsey philosophy of sex education in American schools using Planned Parenthood as its field representative. The SIECUS "Guidelines for Comprehensive Sexuality Education" are being used in schoolrooms K-12 all across the country. The official SIECUS position equates sodomy (anal and oral sex) with marital sex and even recommends pornography for schoolchildren. These "sexperts" teach a very dangerous, unsafe message that undermines love and violates human dignity.

KINSEY'S PERSONAL BEHAVIOR

Although a married man with children, Kinsey was a homosexual sadomasochist who cruised gay bars. He ran his institute as a free sex zone and documented on film many of the sexual encounters that went on behind his sound-proofed, locked laboratory. Toward the end of his life, Kinsey began to condone pedophilia and believed that there was nothing wrong with adults having sex with children.

KINSEY'S LEGACY

As a result of the Kinsey Reports glorifying "sexual satisfaction" as the foundation for marital happiness, society began to change. The divorce rates skyrocketed with no-fault divorce. Adultery, abortion, the sex therapy industry and the explicit sex in entertainment soon became commonplace.

Kinsey assured his readers that "medical techniques which are now available can prevent overall disease from becoming a matter of much social importance." Today the cost of sexually transmitted diseases (STDs) amounts to billions each year. STDs are now epidemic in the teenage population.

Kinsey died in 1956 but his legacy lives on.

Kinseyan sexology must be removed from our educational systems, counseling, medicine, government, law and national life. American parents must insist that this nation return to honesty in developing law and public policy. We must restore our common law as the moral authority for human sexuality.
